

KCC Small Capital Grant Scheme for Sport Privacy Policy

At Kent Sport, we're committed to protecting and respecting your privacy.

We aim to provide you with the highest quality service whilst you are accessing our services. To do this, we must keep records about you and the services we provide for you. We aim to maintain high standards, adopt best practice for our record keeping and regularly check and report on how we are doing.

We will:

- only collect personal data for specified purposes
- explain why we are collecting personal data
- where necessary, seek consent relating to the use of personal data
- retain personal data securely and
- only hold personal data for a specified amount of time after which it will be deleted.

Who are we?

Kent Sport and Physical Activity Service (Kent Sport) is a service within and part of Kent County Council. Kent County Council is the data controller and is responsible for the security of the data that you provide and for overall compliance with data protection legislation. We are an integrated team of Kent County Council and Sport England funded staff, working together as the County Sports Partnership for Kent. We work with partners and networks across the county to provide opportunities for everyone to get involved in sport and physical activity for enjoyment as well as wider health and social outcomes.

How do we collect information from you?

We obtain information about you when you contact us for advice regarding the Small Capital Grants Scheme for Sport, either directly or through a partner (for example a national governing body of sport or local authority). This will usually be through a contact, application or registration form submitted to us, either:

- digitally through our website or a partner website or by email;

- by telephone or face to face contact;
- as a hard copy sent to us through the post or passed to one of our staff in person.

What information do we collect?

The personal information we collect will usually include your name, contact details and information required for the Small Capital Grants Scheme application. We will state clearly the information we will be collecting when you apply.

If your application is successful then we will collect financial information for your organisation in order to make the grant payment. We will share this information with the Kent County Council Finance department so that they can make the payment to your organisation.

If your application is successful, then we will also ask you some monitoring questions. This is for reasons of public interest to ensure equality of opportunity or treatment. The data is aggregated and anonymised and no individually identifiable information is shared.

How is your information used?

For the application process, we rely on the performance of a contract as the lawful basis on which we collect and use your personal data. We may use your information to:

- process applications that you have submitted in accordance with the relevant criteria and terms and conditions.
- to carry out our obligations arising from any funding agreements entered into by you and us.
- seek your views or comments relevant to the Small Capital Grants Scheme for Sport that you have applied for.
- notify you of changes to our services.
- send you communications which you have requested and that may be of interest to you.

How long will we hold your information?

We review our retention periods for personal information on a regular basis. We are required by law to keep some information, but in general we will only keep personal information for as long as is necessary, which in the case of most capital projects will be held by us for the duration of the project and two years after.

Who has access to your information?

Only Kent Sport will have access to your complete application.

When we process your application, we may contact the National Governing Body or other appropriate organisations to confirm eligibility or share the outcome of your funding application.

If your application is successful then the name of your organisation and the amount of the award will be made publicly available as part of the Local Government Transparency Code 2014. No personal data relating to an individual will be published in this way.

We will not give or sell your information to third parties or share your information with third parties for marketing purposes.

Kent Sport website

In order to provide our online services we work with our digital development partners (Red Bullet), who help us manage our website (www.kentsport.org). When you provide information through our website, they act as data processors for Kent Sport and only process personal information in line with our instructions. They will have physical access to data collected through our website in order to do their essential works but will never use or access it outside of supporting us to resolve any technical issues.

None of your digital personal identifiable information is ever shared with anyone outside the process of submitting and storing your data at Kent Sport.

Your Rights

Under the GDPR you have a number of rights which you can access exercise free of charge which that allow you to:

- Know what we are doing with your information and why we are doing it
- Ask to see what information we hold about you
- Ask us to correct any mistakes in the information we hold about you
- Object to direct marketing
- Make a complaint to the Information Commissioner's Office

Depending on our reason for using your information you may also be entitled to:

- Ask us to delete information we hold about you
- Have your information transferred electronically to yourself or to another organisation
- Object to decisions being made that significantly affect you
- Object to how we are using your information
- Stop us using your information in certain ways

We will always seek to comply with your request however we may be required to hold or use your information to comply with legal duties.

Keeping your personal information secure

We have appropriate security measures in place to prevent personal information from being accidentally lost, or used or accessed in an unauthorised way. We limit access to your personal information to those who have a genuine business need to know it. Those processing your information will do so only in an authorised manner and are subject to a duty of confidentiality.
